This Second Amendment is made and entered into on this 12th day of December, 2022 and is an amendment to the Declaration of Covenants, Conditions, Restrictions and Easements for The Valley Lakes Community (the "Declaration") recorded on June 19, 1998 as Document No. 4154272 with the Recorder of Deeds for Lake County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A," which is attached hereto and made a part hereof.

This Amendment is adopted pursuant to the provisions of Article XI, Section 11.2 of the Declaration. The text of this Amendment, which is set forth below, shall become effective upon recording in the Office of the Recorder of Deeds, Lake County, Illinois.

RECITALS

WHEREAS the Declaration subjects certain developed property to the Declaration as legally described in Exhibit B thereto; and

WHEREAS pursuant to Article IV, Section 4.2(d) of the Declaration, the Board of Directors (the "Board") of The Valley Lakes Community Association, Inc. (the "Association") has the power to buy or hold legal title to real property for on behalf of the Members of the Association; and

WHEREAS subject to approval of this Second Amendment by the Voting Members, the Board shall acquire a certain parcel of real property located at the Southeast corner of Nippersink Road and Wilson Road (the "Parcel"), as described in Exhibit A attached hereto, to be added the developed property described in Exhibit B to the Declaration as part of the Community Areas at the Association; and

WHEREAS the Parcel will be acquired by way of a donation to the Association from its current owners;

WHEREAS the Parcel is approximately 39 acres of mixed woodlands and wetlands and will be subject to a Conservation Easement; and

WHEREAS the Board believes it is in the best interest of the Association to acquire the Parcel in order to help preserve the value of homes at the Association by preventing future commercial or residential development of the Parcel; and

WHEREAS the Board and Voting Members of the Association desire to amend the Declaration for purposes of subjecting the Parcel to the terms of the Declaration; and

WHEREAS this Amendment is adopted pursuant to the provisions of Article XI, Section 11.3 of the Declaration. Said section provides that amendments to the Declaration, other than those authorized by Section 11.1, shall be proposed and adopted in the following manner: (a) Notice of the subject matter of the proposed amendment shall be included in the notice of the meeting of the Members of the Community Association at which such proposed amendment is to be considered and shall be delivered to each Member of the Community Association; (b) At such meeting, a resolution to adopt such an amendment shall be proposed by either the Board of Directors or by Members of the Community Association. Such amendment must be approved by Unit Owners holding at least sixty-six percent (66%) of the total allowable votes in the Community Association: provided, however, that (i) any amendment which materially and adversely affects the security of any mortgagee must also be approved by such mortgagee; and (ii) any amendment must be approved by Declarant during any period in which Declarant or an affiliate of Declarant owns any part of the Property; and (c) the approval by the required percentage of the Unit Owners and, where required, the approval by Declarant and of any mortgagee, to any amendment of this Declaration shall be evidenced by their respective execution of consent to such amendment. Any such amendment of this Declaration shall become effective only upon recording in the office of the Recorder of Deeds of Lake County, Illinois, or upon such other date as may be specified in such amendment.

NOW, THEREFORE, the Board of Directors for the Association and the Voting Members of the Association hereby amend the Declaration as follows.

- 1. The real property described on Exhibit A attached hereto and made a part hereof (the Parcel) is hereby subjected to the Declaration as Community Areas.
- 2. Exhibit B to the Declaration is hereby replaced with Exhibit B attached hereto which includes the Parcel.
- 3. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.

This Second Amendment to the Declaration of Covenants, Conditions, Restrictions and Easements for The Valley Lakes Community is approved and executed by an instrument in writing,

signed and acknowledged by the affirmative vote of Unit Owners holding at least sixty-six percent (66%) of the total allowable votes in the Community Association.
